### **RESIDENTIAL SERVICES**

Glenkirk's independent living, foster-style, and CILA residential offerings served 140 individuals in 21 beautiful, community-situated residences in Chicago's northern suburbs and north shore communities in FY 2019.

In FY 2019, Glenkirk opened a 4-person, fully-accessible CILA in Elk Grove Village serving individuals requiring ambulation support and a 2-person Family Living Arrangement (FLA), foster-style host family site. Glenkirk also opened its second Smart Home at its existing Acorn CILA site in early 2019. Glenkirk Smart Homes include digital assistants in each room, a smart TV, refrigerator and lighting, as well as connected doorbells and thermostats to maximize each person's control over their home environment. Glenkirk will open its third and fourth smart homes in mid FY 2020.

In FY 2019, Glenkirk expanded its Health & Wellness program to 12 additional CILA homes, for a total of 20 homes now participating. The program empowers CILA residents and staff to make healthy nutritional choices and provides opportunities to participate in local, fun, and healthy community outings.

### **DAY SERVICES**

In FY 2019, Glenkirk's 7 community day services program sites served more than 260 individuals, providing specialized sensory integration, therapeutic and vocational programs, as well Community and social skill building.

Glenkirk's 2 Next Generation Services program sites in Glenview and Highland Park offered 28 individuals an alternative to traditional workshops providing individuals with opportunities for community integration and social connection.

Last year NGS participants visited the Brookfield Zoo and North Shore Center for the Performing Arts in Skokie, participated in horseback riding through the Equestrian Connection, took nature walks at Diamond Lake, and took part in many other activities at local destinations. Participants also volunteered at Deerfield Food Pantry, Feed My Starving Children and Journeys among other worthy organizations.



paid-work and community job opportunities

### **EMPLOYMENT SERVICES**

In FY 2019, Glenkirk's Employment Services supported more than 70 individuals to prepare for, achieve and maintain community-based employment at local businesses and to participate in on-site paid work at its day programs in Northbrook.

Over 20 individuals were supported in competitive, community-based employment settings at local businesses. Individuals who choose to pursue community employment receive job development, resume building, and on-site job coaching, as necessary.

In FY 2019, we continued to expand our network of partner businesses in order to offer employment opportunities in the community. FY 19 employer partners included Mariano's in Bannockburn, Northbrook and Vernon Hills; Jewel Osco in Mundelein and Highland Park; Dicks Sporting Goods in Northbrook; Chuck E Cheese in Vernon Hills; Aaramark in Evanston and Portillo's in Deerfield.

### **CLINICAL SERVICES**

Glenkirk's on-site Medical Clinic in Northbrook served more than 180 individuals, providing primary and specialty medical care, as well as behavioral health services.

Over 3,400 medical appointments were coordinated through the Medical Clinic for an average of 109 individuals monthly. A wide range of medical services are available through the clinic, including primary care, women's health services, as well as vision, psychiatry, dietary and dental services.

Over 150 individuals participated in Life Balance Services (LBS) on-site or in their home setting. Individuals were provided 11,168 hours of behavioral health supports and therapeutic services including individual and group counseling and therapy. Individuals in LBS benefit from services which promote personal growth and development, as well as increase self-esteem and social connectedness.

# meaningful job opportunities

### **OPPORTUNITY SECURE DATA DESTRUCTION**

In FY 2019 our social enterprise program, Opportunity Secure Data Destruction provides secure document and media destruction services to 280 businesses, and supported meaningful job opportunities for 14 individuals.

OSDD is a market-facing company providing secure document and media destruction services to businesses of all sizes. Over the past 4 years, revenue from service fees has grown, while generating a healthy profit, all of which goes back into supporting Glenkirk's mission.

In FY 2019, OSDD destroyed 6.2 million pounds of paper and generating nearly \$1 million in revenue.
